HUD RULING

WASHINGTON - U.S. Housing and Urban Development (HUD) Secretary Shaun Donovan announced on January 30, new regulations intended to ensure that HUD's core housing programs are open to all eligible persons, regardless of sexual orientation or gender identity. Donovan previewed the announcement at the 24th National Conference on Lesbian, Gay, Bisexual and Transgender (LGBT) Equality - Creating Change. "The Obama Administration has viewed the fight for equality on behalf of the LGBT community as a priority and I'm proud that HUD has been a leader in that fight," said Secretary Shaun Donovan. "With this historic rule, the Administration is saying you cannot use taxpayer dollars to prevent Americans from choosing where they want live on the basis sexual orientation or gender identity - ensuring that HUD's housing programs are open, not to some, not to most, but to all."

LGBT ELDERS

Special Report on LGBT Elders - by Frank Howell

At the Commonwealth Club on January 26th a special panel of four experts was assembled to address the subject of LGBT mental and physical health concerns. The four speakers were: Brian de Vries, Professor of Gerontology, San Francisco State University, policy advisor to the AARP Gustavo Serina, member of the Commission on Aging and Adult Services, City and County of San Francisco, Moli Steinert, Executive Director, Stepping Stone, Marvin Burrows, a founding member, Lavender Seniors of the East Bay and the Lighthouse Community, Hayward. Dr. de Vries concentrated on significant demographic facts regarding LGBT elders: The majority of gay men live alone and have no children to look after their needs. They are not married; 12% have never been in a relationship. Their only family of choice consisted of close friends. These seniors have higher rates of disability. (Continued on page 2)

(Continued from front page) and poor health like cancer; they are less likely to have health insurance; they suffer from a rate of mental depression that is two and one half higher than the general population: 80% feel they cannot come out of the closet when living in old age care facilities.

LGBT ELDERS

Gustavo Serina is an arts writer for the Bay Area Reporter and is active in several LGBT organizations. Mr Serina had a lover for 41 years until his partner died. The couple did an excellent job of estate planning and crafted an advanced health care directive. Moli Steinert, was director of Open House for many years, which fought for special housing for seniors. She is on the San Francisco Long Term Care Committee. Moli highlighted the need for housing built on a single level, with no stairs, mobility is crucial. Stepping Stones is attempting to create affordable housing for elders who face the challenge of isolation and AIDS. Marvin Burrows is quite active with the Hayward Meals on Wheels program and also Marriage Equality USA. Marvin spent 51 years with his lover Bill Swenor. He met Bill when he was 17 years of age. They held joint bank accounts and moved to California together from Michigan. They became registered domestic partners with the state.

Marvin is a founding member of the Lavender Seniors of the East Bay, first conceived in 1994. Lavender Seniors holds monthly potlucks in three East Bay locations and holds an annual event each year called Aging in Place, which advocates keeping seniors in the home and avoiding institutional care. They also have a friendly visitors program.

In 20004 Marvin and Bill were married but a few months later California voided their union. When Bill died in 20005 his pension plan benefits were denied to Marvin because he was considered a single man and not a marriage partner. But a local gay rights organization came to his aid and Bills labor union voted to extend full pension rights to Marvin. This is now considered a major legal victory in LGBT history for gay couples.

Health Care Reform Law Saves 3.6 Million Americans \$2.1 Billion-Nearly 3.6 million people with Medicare saved \$2.1 billion on their prescription drug costs in 2011 due to the Affordable Care Act, according to data issued on Thursday by the Department of Health and Human Services (HHS). According to the HHS report (http://1.usa.gov/yFFyex), the average person with Medicare will save nearly \$4,200 by 2021 because of the new law. "The data proves that the Affordable Care Act helps seniors," said Barbara J. Easterling, President of the Alliance. "It decreases prescription drug costs, provides free preventive care, and slows the growth of Medicare premiums for physicians services." ." According to USA Today (http://usat.ly/wdiNyF), statistics also show that premiums for Medicare Advantage private insurance plans have dropped an average of 7%, and enrollment has grown by 10%, thanks to the 2010 health care overhaul. "This trend counters opposing predictions of dire consequences to enacting health reform, which included a drop in enrollment and a rise in premiums," said Ruben Burks, Secretary-Treasurer of the Alliance.


